# **Business Continuity Consulting**

The Business Continuity practice combines business process, people, technology and risk management skills to address the complex challenges surrounding operational risk and resiliency. # **Business Continuity Program Assessment**

We assess and benchmark BCM Program capabilities, practices, and effectiveness against established measurement criteria. Using the ISO 22301 standard or the FFIEC Guideline for approach and content, Sungard AS will partner with you to assess your Business Continuity Program and identify gaps against industry best practices.

# **Business Impact Analysis**

We prioritize continuity requirements by assessing your business disruption risks, analyzing the impacts of disruptions to your facilities, workforce, technology operations, and vendors, and ranking business impacts to focus efforts on protecting your value chain. Through a series of discovery and planning workshops, Sungard AS will identify and quantify the potential; impact to the organization of an unplanned business interruption. Sungard AS will analyze these impacts, will prioritize business processes as well as the resources upon which they depend (e.g., mission critical applications, vendors, people, and facilities) and identify strategies for ensuring the availability of those key business processes and dependencies.

# **Risk Assessment**

Internal – This activity provides a proactive means for your management to support their business availability objectives. The service identifies and assesses risks that can disrupt your critical business operations and prioritizes recommendations that can

reduce operational risk to acceptable levels. Our Risk Assessment provides the identification of likely threats (natural or man-made event) affecting your organization, the subsequent impact or effect of a threat's occurrence, and the mitigation measures (Risk Controls) that are in place to reduce a threat's likelihood of occurrence and its subsequent effect. Third Party – Sungard AS provides an independent perspective that addresses management or board-level concerns. We identify areas of risk relative to 3rd parties that can be evaluated internally for subsequent action.

# **Continuity Strategy and Planning**

Using the ISO 22301 standard as a guideline for approach, Sungard Availability Services will partner with the Client to build robust Business Continuity Strategies and Plans. Business Continuity Plans reduce risk and improves your business resilience and ability to recover by pre-determining decision processes. # **Exercise Program**

This establishes the framework for a sustainable BC Exercise Program based on ISO Standards 22301, FFIEC and ISO 22398. This includes conducting exercises to validate recovery capabilities while uncovering gaps to enable plan updates and improve the ability to overcome a disaster.


